# Société Générale Insurance strengthens its presence in Serbia

**Sogécap**, the life insurance company of Société Générale Group, has obtained from the supervisory bodies, all the necessary authorizations for the launch of its life insurance business in Serbia.

Held jointly with Société Générale Srbija, the retail banking subsidiary of Société Générale group, **Société Générale Osiguranje** (51% Sogécap, 49% SG Srbija) will market a personal protection insurance offer and savings product designed for the clients of the bank's 92 branches.

The launch of this new subsidiary completes Sogécap's strategy providing Life and Personal protection insurance in Serbia, where it has already established, jointly with Société Générale Srbija, a pension fund company called Société Générale Penzije.

The Life and Personal protection business line is now established in fifteen countries.
