## Strong participation of Societe Generale employees in the third edition of Citizen Commitment Week

Throughout the world, Societe Generale's employees mobilized more than ever for the third edition of Citizen Commitment Week held from 10 to 18 June 2010.

Forty-three of the Group's countries took part in this week-long event dedicated to charitable organizations that are Group partners, participating in close to one hundred local initiatives. This allowed employees to become involved in volunteer activities, fundraising or the collection of objects. In total, more than 26,000 volunteer hours were donated by the employees and close to €350,000 was collected for social actions. In 2009, 37 countries participated and achieved a total of 21,000 donated hours.

In France, the commitment of our employees took the form of:

- Support to 27 partner associations
- The active participation of 555 volunteers
- The organization of 54 social actions in various regions
- The collection of more than €163,000 in donations.

Based on this success, employees worldwide have already marked their calendars for the 2011 event, which will take place from 6 to 10 June.

"I am very proud of the mobilization of the Group's employees for this third edition of Citizen Commitment Week. Our commitment over time, whether to our customers in our business activities or in our support of community life, is part of our culture. It is in this spirit that we will continue to develop our citizenship actions, in particular through the Societe Generale Corporate Foundation for Solidarity, by giving our teams the opportunity to get personally involved," stated Frédéric Oudéa, Chairman and Chief Executive Officer of the Societe Generale group.
