Fiona comes from RBS where she was Head of Energy & Resources, EMEA. She joined in 2001. She has also worked in senior roles for ABN AMRO, Deutsche Bank and Citibank in the US, UK and Australia.

These appointments take place in the context of the plan announced by the bank last year to strengthen its senior bankers and M&A specialist teams, in order to develop its investment banking activities on a global basis.

Fiona Paulus

Fiona Paulus is Head of Coverage & Investment Banking UK at Société Générale Corporate & Investment Banking. Previously, Fiona was Head of Energy & Resources for Europe, Middle East and Africa at RBS. She spent 2008 setting up a global coverage team for private equity firms worldwide in her role as Global Head of Financial Sponsors. From 2003 to 2008, Fiona was the Global Head of Energy & Resources at ABN AMRO Bank (bought by RBS in 2007). Fiona also set up (in 2003) and led the Metals & Mining sector banking team. Fiona joined ABN AMRO in July 2001 from Deutsche Bank, New York where she ran the Telecom, Media & Technology business for Latin America. She worked for 3 years for Deutsche Bank/Bankers Trust, 3 years for JP Morgan Chase, and 13 years for Citibank. From 1989 to 2001, Fiona spent 12 years in Latin American investment banking.

In total, she has spent over 27 years in investment banking, 10 of them in New York and 2 in Australia. Fiona has worked across many product areas including FX, Derivatives, securitisation, debt capital markets, leveraged finance and corporate finance.
