- Thematic Index, encompassing a wide range of alternative strategies that gives exposure to global emerging markets.

They are based on Lyxor's hedge fund platform that covers all the major hedge fund strategies and benefits from a high level of transparency and risk control, while ensuring weekly liquidity. Each index is reviewed and rebalanced on a monthly basis inline with investment guidelines and reflecting the evolution of assets under management and liquidity constraints.

Lyxor will provide investors with a range of investment solutions including onshore and offshore investment vehicles, enabling investors and UCITS managers to execute efficient diversification and allocation strategies based on the indices.

Owned by Société Générale Index, the indices are calculated and published on a daily basis by S&P on Bloomberg and Reuters.
