SG ISSUES NEW RANGE OF UK COVERED WARRANTS INCLUDING WARRANTS ON US UNDERLYINGS

MARKET SENSITIVE INFORMATION: NOT TO BE RELEASED BEFORE 16H30 HOURS

SG, a global leader in covered warrants, today announced the launch of 44 new warrants issued on 15 underlying stocks and indices including US companies such as IBM, Yahoo! and Microsoft. The new warrants will be issued on the London Stock Exchange and will be tradable from Monday, 25 November.

SG is the first and only UK issuer to provide warrants on major European and US stocks, all priced and settled in GBP. SG is also the only issuer who provides puts and calls on all products, allowing investors to take both bull and bear positions, a choice which is crucial under current market conditions.

In the UK, SG now offers a total of 86 warrants on 23 underlyings, covering 13 UK blue chips, 5 major global indices and several leading US and European stocks. This makes SG the single largest issuer in the UK (both in terms of total number of warrants and the range of underlyings offered) and brings the total number of warrants issued on the LSE from 171 to 215 and the total number of underlyings from 22 to 37.

"We are more than satisfied with the results over the first four weeks of the market," said David Lake, Director of UK Warrants for SG. "The positive feedback we have received from brokers and investors makes us confident that the market will go from strength to strength." While volumes remain modest, with around 30 trades a day, there is a steady increase in trading sizes as investors gain confidence. "SG has received over 1,000 registrations to date via our website, www.warrants.com," added David.

Charles Annandale, Head of Equity Derivatives in the UK, said "We are extremely pleased to take the next step in expanding our range of warrants. It is particularly exciting to enable UK investors to invest in major US and European stocks which trade and settle in sterling. Our expanding range of warrants on diverse UK and US underlyings brings us in line with our objective of being the UK market leader."
