Société Générale will train 900 young people in 2009 thanks to its part-time training programmes

Société Générale is committed to offering part-time training programmes. In 2009, 900 young people from different backgrounds will join the Group and receive training and support throughout the program from a dedicated individual tutor. Last year, Société Générale had 1 600 students enrolled in a six to thirty-six month part-time training programme.

Part-time training programmes give graduates the opportunity to follow a recognised professional training course. They can then use this as a first step to finding a job within the Société Générale Group.

- For those who already have significant professional experience but no particular qualification, the Group can provide the opportunity to study towards a vocational Baccalaureat or other qualification by offering a professional training contract to work as Customer Service Officer or a Multi-media Customer Advisor.
- Graduates can work in sales (Private Customer Advisors) by obtaining an advanced training certificate in Banking, or Negotiation and Customer Relations or in non-sales jobs (back office managers, accountants, IT specialists etc.).
- Those holding a Baccalaureat degree and 3 to 4-year higher education diploma can train to become business managers and branch managers by studying towards a 1st or 2nd Masters or a business school qualification; they can also obtain positions as "sell-side" analysts.
- Part-time training programmes are also accessible to students with disabilities.

The success of these part-time training programmes shows that jobs within the banking sector are growing. Société Générale is currently offering permanent employment contracts upon completion of programmes in order to help young people secure employment.
