## CONTINUING THE TRANSFORMATION: NEW ORGANISATION SET UP

As announced on 13 February 2013, Societe Generale has entered a new phase of its transformation to reinforce its universal banking model centred on three pillars of excellence, and to continue to adapt the changing expectations of its clients and to new economic and regulatory situation.

Effective from 2 September 2013, the new organisation comprises three core divisions:

- The French Retail Banking division, which maintains its current scope (the Societe Generale -French Network, Crédit du Nord, Boursorama)
- A new international retail banking, financial services and insurance division ("International Banking and Financial Services"), jointly headed by Didier Hauguel and Jean-Luc Parer.
- A new corporate & investment banking, private banking, asset management and securities services division ("Global Banking & Investor Solutions"), headed by Didier Valet.

This new set up will improve the Group's commercial and operational efficiency in the service of clients by reinforcing synergies between businesses and by simplifying internal operating structures and methods.
