In the 2018 Survey, Societe Generale ranks No. 5 for Overall Research.

The main results of the Extel 2018 Survey are as follows:

- #1 Global Strategy
- # 1 Multi Asset Research
- #1 Index Analysis
- # 1 Quantitative Research
- #5 Overall Research

The bank continues to be ranked **No.1** in **Global Strategy Research**, for a record breaking 15th year in a row and **No.1** in **Multi Asset Research**, for the 11th consecutive year. The research department is also ranked **No.1** in **Index Analysis** for the third time, and **No.1** in **Quantitative Research** for the second time in a row.

Regarding Equity Research, seventeen sectorial teams have been named in the Top 10 of their respective category of which nine are in the Top 5 (among which Beverages 2nd, Food 2nd, Household Products & Personal Care 3rd, Media 3rd, Oil Services 3rd, Oil & Gas 4th, Real Estate 4th, Luxury Goods 5th).

These rankings once again demonstrate the long-term efforts by Societe Generale Corporate & Investment Banking to offer its clients the best in class research, in order to help them in their strategic investment decisions across asset classes as well as sector and macro-economic insights.
